
# REMEDY The Voice from the Past Recalling **Memories in Diversity**

# PRESENTATION

Due to the generation gap in understanding of the historical events concerning the totalitarian regimes, ostracism and their victims, it is important to draw attention of younger generation to these topics in order to eliminate the gap of understanding. The project "REMEDY", attempts to create favorable conditions for revealing and remembering the painful moments in the history of EU nations. Regarding the general objectives, the aim of REMEDY is to promote the diversity of historical events, and in turn, foster understanding of every nation's individuality. We believe that by understanding the perspective of each country, and by commemorating each other's losses and tragedies, we can eventually contribute to the elimination of not only the generation gap, but also the nation gap, in the light of the new "European" identity.

### AIMS

REMEDY aims to emphasize the importance of remembering the past, commemorating the totalitarian regime victims and appreciating the present.

Regarding the specific objectives, "REMEDY" focuses on the positive side of history, since the establishment of the EU brought peace and democracy. Although, the price for peace was too high, and right now it is a fragile thing to take for granted, EU society shall participate in reflection on the past in order to appreciate and develop the present. Therefore, by looking back on the wider national and EU historical context of the period, main goal of REMEDY is to promote positive dialogue between different target groups of the society, including older and younger generation. Understanding what older generation have experienced in a very different society, will enable youth to seek new paths to effectively protect the freedoms and civil rights in the modern EU community.

Involving 10 EU partners, the project can approach wide range of target groups, reached through the workshops organised in every partner country over the period of 18 months. The project will consist four international events.

# IMPLEMENTATION

The goal of "REMEDY" is to spread awareness about these issues above, hear out the stories about the past, educate wider public and youth about the consequences of these events and lessons we can draw from them. This will be ensured through the organization of 4 international events and 10 national workshops. REMEDY is relevant in the light of current refugee situation, which brought huge resonance, in some cases even fear and prejudice in the EU. Through communication and reflection it is possible to fight the hatred and prevent fatal consequences of the past history.

Main goal is to bring these countries together for reflection on causes, commemoration of victims, and reconciliation. The lessons of the past are relevant today for the reason of unity and forgiveness, moving to the brighter future of diversity and shared values. "REMEDY" reaches to older and younger generation about the issue of ostracism, anti-Semitism, hostility towards immigrants using the necessary tools to combat these issues. This project is one of the tools in the path of creating the bridge of understanding that contributes to the reconciliation.

### **Expected results**

The ultimate result of this project would be a new Relation build on understanding, unity and forgiveness, moving to the brighter future of diversity and shared values.

# WHAT IS THE OPRI

The International Project Office (OPRI) is an office linked to the Vice-rectorate of Research, responsible for the management of international research projects at UCAM. The OPRI was founded to strengthen the collaboration between our partners all around the world in the field of research. The unit was established in 2012 and has built strong alliances in 36 countries in which the university has to date participated in 41 projects. The internationalization of the Catholic University of Saint Anthony, through the OPRI, is directed towards all of the university community, researchers as well as students. A total of 160 students have participated already in projects in a variety of countries all over the continent.

Currently we are leading international projects like "EUROLAB-4HPC", "ACDDTHPC" and "Discovery of novel blood anticoagulants using hybrid artificial intelligence techniques" in the area of computational bioinformatics inside the calls Horizon 2020, 7FP and NILS. UCAM also has been awarded a postdoctoral Marie Curie with the project "POCBIOPEP" related to the study of cellular markers in blood from the intake of POrk Cured BIOactive PEPtides. Likewise, the UCAM, recognized by European institutions for its work in research and management of sports projects, such as dual career (education + sport) is coordinating the projects "ESTPORT" and "SPIIS" inside the call Erasmus+ Sport.

- 1 Increase international presence UCAM in the European Union through participation in networks of knowledge, technological and scientific platforms, dissemination seminars, technical conferences and other events promoting R&D organized by the EU, with the presence of renowned professionals.
